- 4. The Principal has applied for continuation of provisional affiliation to these programmes for the academic year 2024-25, vide paper read as (6).
- 5. - 6. Orders are issued accordingly subject to the terms and conditions specified thereunder:
 - Affiliation granted is strictly provisional, and only for the academic year 2024-25.
 - The Principal shall strictly follow the syllabi available in the University website www.uoc.ac.in for selecting complementary courses.
 - The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/ for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
 - Selection and admission shall be made only on the basis of the rules and regulations of the

University/ Government and on the basis of the directions issued by the University/Government from time to time.

- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.

- 1. The Principals of various Colleges had submitted applications for additional affiliation of programmes for the academic year 2024-25, vide reference cited first.
- 2. After completing all the statutory procedures, including inspection by the District Level Inspection Commissions constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to the Government, vide paper read as second to forth, for obtaining views, as stipulated in Calicut University First Statutes, 1977.
- 3. The Government of Kerala accorded Administrative Sanction, vide reference cited fifth to seventh, and issued No Objection Certificate, vide G.O cited eighth to tenth, for starting new self-financing programmes for the academic year 2024-25, subject to the terms and conditions specified in the said G.Os.
- 4. Having received Administrative Sanction and No Objection Certificate from the Government, the Principals of the following colleges have submitted request for granting provisional affiliation to the programmes as detailed below.

The same meeting of the Syndicate, vide item No. 2025.278 A* has also resolved to grant provisional affiliation for starting B.Com Finance Honours (40 seats) & M.Sc Microbiology (10) at Ma'din Arts and Science College, Melmuri, Malappuram for the academic year 2024-25 with permission to start classes from the academic year 2025-26.
- 7. The Vice Chancellor has accorded sanction to implement the above resolutions of the Syndicate.
- 8. Orders are issued accordingly subject to the following terms and conditions:
 - Affiliation granted is strictly provisional and only for the academic year 2024-25.
 - The college has to apply for Continuation of Provisional Affiliation for the ensuing academic years remitting the fee fixed by the University.
 - The Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by the Government with regard to the procedure of admission, collection of fees and other regulations.
 - Admission to the next academic year shall be made only after obtaining prior permission from the University.
 - Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.
 - The Principal shall follow the approved syllabus of the University.
 - In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted to the college will automatically be cancelled.
 - Violation of the above may lead to cancellation of affiliation.
