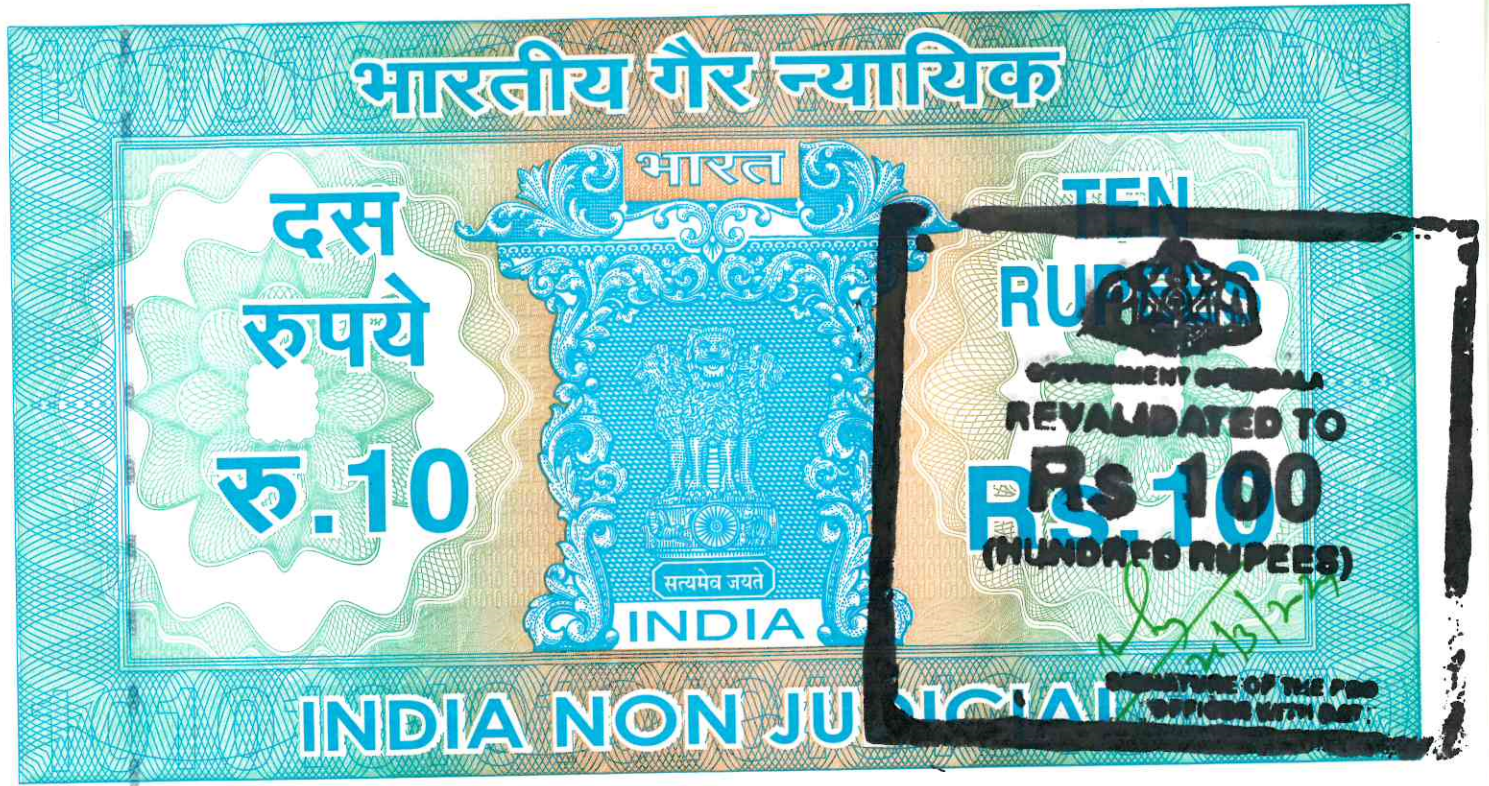

1. Purpose:

The purpose of this MoU is to establish a framework for collaboration between Najath College of Science and Technology and KSHM Arts and Science College for the mutual benefit of both institutions.

2. Areas of Collaboration:

- a. **Academic Collaboration:** Both institutions agree to explore opportunities for joint academic programs, research projects, and faculty exchange programs.

5. Termination:

Either party may terminate this MoU by providing a written notice of termination to the other party at least days prior to the intended date of termination.
