By this MoU following activities will be executed accordingly

1. Najath College will establish a UGC NET coaching initiative in its premises.
2. Najath College will co-ordinate the marketing, admission procedures, and the basic infrastructure facilities for the students who have taken admission.
3. Cyra Learnings will provide systematic UGC NET coaching for all the aspirants who have taken admission through its coaching mechanism including Cyra Learning App.
4. Both the parties will work dedicatedly to make the UGC NET Coaching initiative under Najath College a success. .
5. As a fee for providing UGC NET Coaching materials for the aspirants, Cyra Learnings will charge and collect a fee of INR-8000 from each aspirants/students in a four time installment basis.

Clause 1
CO-OPERATION

1.3 This collaboration will give the Second Party an opportunity to make sure that the students taken admission in UGC NET coaching initiative is getting systematic and up-to-date coaching.

Clause 2
SCOPE OF THE MOU

2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community in their preparation for the UGC NET coaching.

2.2 The First Party will provide systematic coaching for the students who have taken admission to the UGC NET coaching initiative established under the second party.

2.3 The collaboration between first party and second party will make sure that the aspirants are getting a systematic and syllabus oriented coaching from NET/JRF qualified faculties which will be sufficient to clear the prestigious exam of UGC NTA NET.

Clause 3
Roles and Responsibilities of both the parties

This collaboration is to make sure that all the aspirants who have taken admission under the UGC NET initiative started by second party is getting a proper result oriented coaching based on the syllabus of the exam. So, First party will make sure that the students are getting an effective and systematic coaching based on the syllabus and updated question pattern.

As part of the marketing and boosting, both the parties can use the pictures, videos and other digital contents of the camps and offline sessions. The result also will be the result of both the parties. Both parties can publicize the pictures of the qualified aspirants as their results.

First party is responsible to deliver the course material in a structured format which will be sufficient to help the aspirants in their journey to clear the exam of UGC NET.

Fee follow-ups and collection will be under the responsibility of Second party and it has to be hand over to the first party on time. Second party can collect the payment through the teacher who is in charge of the collection process.

If both the parties are ready to add the fields of collaboration later in time, it can be communicated between both the parties in official formats and if it is agreed by both the parties it can be added to the MoU accordingly.

Payment system:

1. Course fees will be 8000/- which can be remitted as four installments.
2. 2000/- has to be remitted in the time of admission.
3. September-3 is the deadline for second installment of 2000 rupees.
4. October- 15 is the deadline for third installment.
5. November – 21 is the deadline for fourth installment of 2000 rupees.

The fee collection is the responsibility of the second party. Second party is responsible to hand over the fees within 10 days after the deadline for each installment.

If any students failed to pay the fees without any communication with any of the parties, the first party has the right to stop the service after communicating with the aspirant three times.
