1. Purpose and Scope:

 - Implement course syllabus and curriculum as per the direction of Rutronix.
 - Collect fees from students for the courses.
 - Conduct examination
 - Issue certifications upon successful course completion.
- 2.2 The Second Party (Najath College of Science & Technology) agrees to:
 - Provide access to its lab facilities for conducting computer courses as per the time
 Required for
 - Assign a lab assistant/ faculty to support the computer courses.
 - Assist in administrative matters related to course admission.
 - Collaborate with the First Party in deciding course details, syllabus, and fee structure.
- 3. Course Details, Time and Fee Structure:

The details of the computer courses and teaching hours to be offered and the associated fee structure shall be decided upon by mutual consent of both Parties.

4. Admission Procedures:

The Second Party shall be responsible for managing the admission procedures for the computer courses, including advertising, receiving applications, and student enrolment.

5. Confidentiality:

Both Parties shall maintain the confidentiality of any sensitive information shared during the collaboration.

6. Intellectual Property:

Any intellectual property developed during the collaboration shall be owned as agreed upon by both Parties.

7. Duration:

This MOU shall be effective from the date of execution and shall remain in effect until terminated by either Party with [Notice Period] written notice.

8. Dispute Resolution:

Any disputes arising from this MOU shall be resolved through amicable negotiation between the Parties.

9. Governing Law:

This MOU shall be governed by and construed in accordance with the laws of Manjeri Jurisdiction.

10. Amendment and Termination:

Any amendments or modifications to this MOU shall be made in writing and agreed upon by both Parties.
