#### ANTI-RAGGING COMMITTEE

The University Grants Commission has reiterated the ban on the ragging of learners in Institutions of Higher Education as per the guidelines of UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009. The learners admitted in the NCST are therefore directed to strictly desist from any kind of ragging on the college premises.

### **Objectives of Anti Ragging Committee**

Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of a Ragging Free Environment on the college Campus. The main objectives of this committee are as follows:

- To aware the students of the dehumanizing effect of ragging inherent in its perversity.
- To keep a continuous watch and vigil over ragging to prevent its occurrence and recurrence.
- Promptly and stringently deal with the incidents of ragging brought to our notice.
- To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

#### Forms of Ragging

- Display of noisy, disorderly conduct, teasing, excitement by rough or rude treatment or handling, including rowdy, undisciplined activities which cause or are likely to cause annoyance, undue hardship, physical or psychological harm or raise apprehensive fear in a fresher, or asking the students to do any act or perform something which such a student will not do in the ordinary course and which causes him/her shame or embarrassment or danger to his/her life, etc.
- Any act of Indiscipline, Teasing or Handling with Rudeness.
- Any act that Prevents, Disrupts the Regular Academic Activity.
- Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
- Any Act of Financial Extortion or Forceful Expenditure.
- Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- Any Act of abuse by spoken words, emails, SMS or public insult etc.
- Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- Any unlawful assembly or conspiracy to ragging.

# **Punishment Provisions**

Any student or group of students found guilty of ragging on campus or off campus shall be liable to one or more of the following punishments:

- Debarring from appearing in any sessional test/ university examination or withholding results
- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits
- Suspension from the college for one month
- Cancellation of admission

- Debarring from representing the institution in any national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel
- Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period
- Expulsion from the institution and consequent debarring from admission to any other institution
- Fine up to twenty-five thousand rupees
- Imprisonment for a term which may extend to two years or with a fine which may extend to ten thousand rupees or with both
- Collective punishment When the students committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential triggers.
- Any institution that fails to take adequate steps to prevent ragging or fails to act by the Regulations or fails to punish perpetrators or incidents of ragging suitably is liable to the penalties and punishments as per the provisions of the Regulations.

### **Anti-Ragging Committee Composition**

 As per the UGC guidelines, the Anti-ragging Committee of NCST is headed by the Principal and consists of representatives of faculty members including Physical Education, representatives of parents, representatives of students belonging to the fresher's category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of level as well as gender.

also educate the students at large by adopting various means about the menace of raging and related Punishments there too. A gamut of positive reinforcement activities is adopted by Anti-Ragging Squad for orienting students and moulding their personalities for a better cause. They shall work in Consonance and Guidance of Anti Ragging Committee.
